<b>Information relative to the substances used or products of degradation</b>	<p>Overall migration tests are made on similar products. The products meet the requirements regarding overall migration testing to 10% ethanol, 3% acetic acid, 95% ethanol at 40 °C for 10 days and Icooctane for 2 days at 20 °C. According to (EU) No. 10/2011, the materials with contact to food may not release more than 10mg/dm<sup>2</sup> of substances under the course of testing. The tested samples comply with these requirements.</p> <p>Specific migration of primary aromatic amine. In compliance with the requirements of (EU) No. 10/2011. The product sample did not release any excess of primary aromatic amine when subjected to a 3% acetic acid testing, at 40 °C for 10 days.</p> <p>Specific migration of metals. In compliance with the requirements of (EU) No. 10/2011. The product sample did not release any excess of heavy metals when subjected to a 3% acetic acid testing, at 40 °C for 10 days.</p> <p>The product is free from Bisphenol A. Tested through Dichloromethane extraction by ultrasonic bath.</p>
